

## **Medal Paints 2021 “Refresh Your Home with Medal Paints” Competition Terms & Conditions**

1. This Campaign Competition (“Competition”) is organized by Medal Paints (Pty) Ltd (“The Organiser”).
2. The Competition is open to permanent residents and citizens of South Africa, Botswana, Lesotho, Namibia, and Swaziland from the age of 18 (eighteen) years old in possession of a valid Identity Document except any employee, director, member, partner, agent or consultant or any person directly or indirectly who controls or is controlled by The Organiser and/or immediate family members of any employee, director, member, partner, agent or consultant of or person indirectly or directly in control or controlled by The Organizer, advisers, dealers, suppliers identified by the trademarks owned by or licensed to Medal Paints (Pty) Ltd, its affiliates and/or associated companies (“Disqualified Persons”).

By entering the Competition, all participants and winners agree to be bound by these rules which will be interpreted by The Organizer, whose decision regarding any dispute will be final and binding. The Promoter reserves the right to amend, modify, change, postpone, suspend or cancel this Competition and any prizes (which have not yet been subject to a draw), without any notice at any time, for any reason, which The Organizer deems reasonably necessary. The Organizer shall endeavor to give prior notice of such termination or alternation to consumers. In such event, participants without vested rights will have no recourse or claim against The Organizer for a prize.
4. The Competition commences on 01<sup>st</sup> November 2021 and will be run until 31<sup>th</sup> December 2021.

By entering the Competition, participants are required to Buy any Medal branded paint ([www.medalpaints.co.za](http://www.medalpaints.co.za)) instore and WhatsApp a picture of your till slip together with your Name to 071 664 3751. Should the Organiser select the participant as a potential winner the information is made available to Medal Paints Pty Ltd to contact the participants. The Organiser may require the winners to complete and submit an information disclosure agreement and indemnification to enable The Organiser to ensure compliance with these rules. Should any winner refuse or be unable to comply with this rule for any reason, such winner will be deemed to have rejected the prize and it shall revert to The Organiser.
6. Only those participants that meet all of the above criteria will be entered into the selections for the Prizes.
7. The Prize consists of:
  - 10 winners each receiving Medal branded **Paint** “to the value of R5000.00” and **Cash** “to the value of R5000.00”.

9. Winners will need to provide before and after pictures of their homes being painted.

  - 10.1. If any entry was made in a manner which in The Organiser discretion may provide Participant with an unfair advantage over other entrants, unless these terms and conditions specifically allow such conduct, such Participant will be disqualified from this and all future competitions run by the Promoters.

11. The Organiser will run 1 lucky draw to determine, 10 winners from the entries received through Whatsapp. The draw will take place on the 15<sup>th</sup> January 2022. The winner will be determined based on The Organiser' discretion. The Organiser decision is final and no correspondence shall be entered regarding The Organiser selection method. In order for the particular entry to be confirmed as valid, The Organiser authorized agent will call the possible winners and conduct a Competition verification process.
